General Practice Cold Chain Self Audit

Immunisation service providers are required to use this checklist to carry out a selfaudit at least once every 12 months, and more frequently if there have been problems with equipment or cold chain breaches. Documentation should be stored for future reference.

Highlights for 2021 Influenza Vaccine Formulations

A new cell-based influenza vaccines called Flucelvax Quad has been registered for use in Australia for the 2021 influenza season. This vaccine **does not use eggs** in the manufacturing process and therefore does not contain any egg protein. The vaccine can be used in people from 9 years to 64 years of age but is **NOT** funded under the National Immunisation Program (NIP).

The vaccines that are funded are still considered safe to give to people with egg allergies (see Influenza Vaccine chapter in the Australian Immunisation Handbook for detailed information).

ALERT - Vaccine Storage

The Public Health Unit would like to remind practices that placing vaccines in eskies/coolers and transporting them to other practices/facilities (even those within a group of practices) is **NOT recommended**.


Placing vaccines in eskies/coolers is an inherently risky process and should ONLY be done in the event of a vaccine fridge mechanical failure.

Please DO NOT move vaccines in the event of a power failure. Leave the vaccines in the fridge and contact the Public Health Unit for advice on management.

Please DO NOT plan to move vaccines around amongst other practices in the event of over-stocking. Ensure you order ONLY enough vaccine to fit in **your practice fridge** at any one time.

Remember, the influenza and the Covid vaccine (initial dose numbers are likely to be limited) will be able to be ordered more frequently than monthly, so **DON'T** over order.

- Four <u>age-specific</u> influenza vaccines will be available free of charge to eligible people under government funded programs in 2021.
- Before administering influenza vaccine, <u>please check you have the correct</u> vaccine for the person's age.

IMPORTANT CHANGES TO INFLUENZA VACCINE ORDERING

- In 2021, a vaccine pre-allocation system will replace the current pre-order system for first orders only. This is in response to your survey answers from 2020, to ensure equitable distribution of vaccines and to reduce the vaccine wastage.
- Your first order will be pre-allocated based on your previous year's vaccine usage, including expired and
 discarded vaccines. You must review and confirm your order on the NSW Vaccine Centre online ordering
 system website (https://nsw.tollhealthcare.com/). The NSW Vaccine Centre will notify all providers of the
 date when pre allocated orders can be reviewed and confirmed, including instructions on what you are
 required to do to confirm your first order allocation.
- Deliveries of influenza vaccine will commence when vaccine becomes available. The vaccines arrive at
 the NSW Vaccine Centre over a period of several months from April 2021. This means that not all stock
 is available at the start of the vaccination program. NSW Health requests that in subsequent orders,
 practices only order enough vaccines required for use in a maximum four-week period.
- The questionnaire that was recently sent out for practices to report on their 2020 expired influenza
 vaccine stock has now closed. If you have not completed the questionnaire, there is no further action
 required. You will still receive a pre-allocated order.
- If you have submitted an EOI to administer the COVID-19 vaccine, it is important ensure you have enough fridge capacity to store COVID-19 and influenza vaccines
- Once you have received your initial influenza vaccine order and have receipted it on the NSW Vaccine Centre online ordering system website, a subsequent influenza vaccine order can be made online.
- · Ring your local public health unit on 1300 066 055 if you have not already registered for online ordering.
- There will be limits placed on subsequent influenza orders to ensure equitable distribution to all providers in NSW.
- The large volume of influenza vaccine orders to be delivered at the beginning of the season means that it takes around three to four weeks for the NSW Vaccine Centre to send out all first influenza vaccine orders from the system.
- Providers should only schedule influenza vaccination clinics once vaccine supplies are received.
- An A4 influenza information sheet and fridge basket stickers will be sent with first deliveries of vaccine.

- All immunisation providers should apply to have access to the Australian Immunisation Register (AIR).
 Mandatory reporting of influenza and COVID-19 vaccines will be effective from 1 March 2021 and for all
 other vaccines from 1 July 2021. Providers who are currently using the authentication file to access the AIR,
 should apply for PRODA access as soon as possible. The authentication file will be disabled in 2021.
